Local Law No. – 14– of the year 2003

Section 211-2. Definitions.

TO AMEND: ILLUMINATED SIGN – Any sign illuminated by electricity or other artificial light source.

TO ADD: F. Notwithstanding anything to the contrary in this chapter, no sign shall be illuminated by neon gas, any other gas or by phosphorescence, unless the lighting tubes shall be covered by a diffuser.

Section 211-3. General prohibitions.

TO ADD: F. Notwithstanding anything to the contrary in this chapter, no sign shall be illuminated by neon gas, any other gas or by phosphorescence, unless the lighting shall be covered by a diffuser.

Section 211-5. Permitted signs in business areas.

TO AMEND: E. Lighting of signs. No sign shall be illuminated and no permit therefore shall be granted unless said illumination and diffusers shall be approved by the Board of Architectural Review.


