Section 1. Wall Street, Village of Cherry Valley, County of Otsego of the State of New York is designated as a one-way street. The vehicular traffic shall be required to move from Lancaster Street, Village of Cherry Valley to Main Street (NYS Rte. 166), Village of Cherry Valley.

Section 2. This Local Law is to be submitted to the New York State Department of Transportation for inclusion of the Rules and Regulations.

Section 3. This Local Law shall become effective upon filing with the Secretary of State of the State of New York.
