BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF ROTTERDAM

SECTION 1. Local Law No. Five (5) of the Year 2001 which enacted the Official Zoning Map of the Town of Rotterdam is amended as follows:

The zoning district classification comprised of Tax Parcel #12.10-2-5 is hereby changed from B-2 and R-1 to R-3 to allow an existing two-family apartment house and a one-unit apartment house to continue to be utilized in this manner.

SECTION 2. The Official Zoning Map is amended to reflect said change of zoning district classification.

SECTION 3. This local law shall take effect upon filing with the Secretary of State as required by Section 27 of the Municipal Home Rule Law.




