## Local Law No. Seven (7) of the Year 2003

### BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF ROTTERDAM

**SECTION 1.** Amend Chapter 266 of the Code of the Town of Rotterdam entitled, "Vehicle and Traffic" as follows:

A. Install stop signs at the following intersections:

1. Summer Street at its intersection with Woodbridge Avenue (sign to face east).  
Remove Yield sign on Summer Street at its intersection with Woodbridge Avenue.
2. Four (4) way stop at the intersection of Puritan Drive and Crestwood Drive.
3. Dube Street at its intersection with Outer Drive (sign to face east).
4. Maida Lane at its intersection with Edgewood Avenue (sign to face southwest).
5. Ford Avenue at its intersection with Edgewood Avenue (sign to face southwest).
6. Caroline Avenue at its intersection with Edgewood Avenue (sign to face southwest).
7. Three (3) way stop at the intersection of Clyde Avenue and Edgewood Avenue.

**SECTION 2** This local law shall take effect upon filing with the Secretary of State as required by Section 27 of the Municipal Home Rule Law and by posting of appropriate signage.
