Local Law No. 2 of the year 2003

A local law adding new subparagraph (1-A) and amending subparagraphs (2) and (18) of Local Law No. 1 of the year 1981, as previously amended, of the Village of Cleveland relating to the protection, control and management of the Cleveland Water Department and the use of water supplied therefrom, and establishing of the rates to be paid for the uses of water therein.

Be it enacted by the Board of Trustees of the Village of Cleveland as follows:

Section 1. New Subparagraph (1-A) to Article III – Regulations and Prohibitions, Section 5 – Meters, of Village of Cleveland Local Law No. 1 of the year 1981, as previously amended, is hereby amended to read as follows:

(1-A) In the event any charges shall have been delinquent for a period of at least (60) calendar days as of May 15 of any year, the Village Clerk is hereby directed to add the entire amount of the charges, plus penalties and interest as provided for in this law, to Village Real Property Taxes due and owing to the Village in the next succeeding year, and the Village Clerk is directed to collect the same as Real Property Taxes.

Section 2. Subparagraph (2) of Article III – Regulations and Prohibitions, Section 5 – Meters of Village of Cleveland Local Law No. 1 of the year 1981, as previously amended, is hereby amended to read as follows:

(2) Whenever a service has been turned off for non-payment of a water bill, for non-payment of any other charge, for a violation of any Regulations and Prohibitions, or for any other reason, the service shall not be turned on again until all bills and charges have been paid and until an additional fee of \$50.00 for turning on the water service has been paid. The Village Board shall have the authority to amend the fee, from time to time, by resolution.

Section 3. Subparagraph (18) of Article III Regulations and Prohibitions, Section 5-Meters, of Village of Cleveland Local Law No. 1 of the year 1981, as previously amended, is hereby amended as follows:

The Village Board shall have the authority to adopt, by resolution, rules and regulations concerning the interpretation and administration of this Local Law. The Village Board also shall have the authority to amend any service rates, permit charges, connection fees, service installation fees, late payment penalties, metered rates, and any other rates, charges, fees or penalties provided for under any section of this local law, including but not limited to all sections of Article III – Regulations and Prohibitions, by resolution.

Section 4. This Local Law shall take effect upon its filing with the New York State Secretary of State.
