## **BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF ROTTERDAM**

**SECTION 1.** Local Law No. Five (5) of the Year 2001 which enacted the Official Zoning Map of the Town of Rotterdam is amended as follows:

The zoning district classification for a change of zone request from CWLS Developers, LLC, contract vendees of a 26.44 acre parcel of property comprised of Tax Map No. 48.00-2-18, located on the east side of Campbell Road bounded by Rotterdam Square Mall, Old River Road, and General Electric in Rotterdam, NY is hereby changed from Heavy Industrial (I-2) and General Business (B-2) to Multi Family Residential (R-3) to allow for the construction of a 208-unit apartment complex.

**SECTION 2.** The Official Zoning Map is amended to reflect said change of zoning district classification.

**SECTION 3.** This local law shall take effect upon filing with the Secretary of State as required by Section 27 of the Municipal Home Rule Law and by posting of appropriate signage.
