§ .92 Title: This local law shall be known as the Village of Clyde Interim Moratorium regarding Adult Uses and Entertainment.

A. Purpose: This local law is intended to give the Planning Board time to do research and development in order to recommend zoning laws for Adult Uses and Entertainment.

B. Moratorium Upon the Issuance of Adult Uses and Entertainment Permits.
No permits shall be issued for such uses for a period of three (3) months from the effective date of this local law.

This local law shall take effect upon filing with the Secretary of State.
