Chapter 136-45 D (1) Add:

With an awning any permitted "double-faced" sign meeting the area size requirements will be allowed to be placed up to 3 ft. above the first story so that the sign will be above the awning and its path of movement for storage. If the sign is illuminated, the lights shall be positioned and shielded so that there is no direct light into the second story windows. Also the lights shall be "on" only during the operating hours of the business.

Chapter 136-13 (A) C-2 Commercial Development Area Regulations:

Delete: f. South Park Street - from Sodus Street to Glasgow Street.

Change "g." to "f."
