BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF ROTTERDAM

SECTION 1. To amend Chapter 266 of the Code of the Town of Rotterdam entitled, "Vehicle and Traffic", § 266-46. Schedule VI: Stop Intersections, as follows:

- A. Install stop signs at the following intersections:
 1. Install Stop sign on Theodore Road at its intersection with Peter Road (signs to face southwest).
 2. Install Stop sign on Fred Road at its intersection with Peter Road (signs to face northeast).
 3. Install Stop sign on Lucy Road at its intersection with Peter Road (signs to face southwest).

(If additional space is needed, attach pages the same size as this sheet, and number each.)

4. Install Stop sign on Angelina Road at its intersection with Peter Road (signs to face southwest).
5. Install Stop sign on Day Road at its intersection with Peter Road (signs to face southwest).
6. Install Stop sign on Cassella Road at its intersection with Peter Road (signs to face south).
7. Install Stop signs on Paul Avenue at its intersection with Scott Street to create a four (4) way stop zone
8. Install Stop signs at the intersection of Autumn Run and Deer Path to create a three (3) way stop zone.
9. Install Stop signs at the intersection of Country Walk and Deer Path to create a three (3) way stop zone.
10. Install Stop signs at the intersection of Country Walk and Autumn Run to create a three (3) way stop zone.

SECTION 2. This local law shall take effect upon filing with the Secretary of State as required by Section 27 of the Municipal Home Rule Law and by posting of appropriate signage.


