BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF ROTTERDAM

SECTION 1. To amend Chapter 266 of the Code of the Town of Rotterdam entitled, "Vehicle and Traffic", § 266-46. Schedule VI: Stop Intersections, as follows:

- A. Install stop signs at the following intersections:
 1. Vista Boulevard at its intersection with Dunnsville Road. Sign to face east.
 2. Springdale Way at its intersection with Vista Boulevard. Sign to face south.
 3. North Crest Court at its intersection with Vista Boulevard. Sign to face north.

SECTION 2. This local law shall take effect upon filing with the Secretary of State as required by Section 27 of the Municipal Home Rule Law and by posting of appropriate signage.


