Any replacement or repair of an existing structure shall require a permit, including

but not limited to the following:

- a. Roofing and re-roofing
- b. Siding.
- c. Doors and windows, including new and replacement.
- d. Gutters.
- e. The part-for-part repair and replacement of mechanical equipment, including but not limited to furnaces, boilers, water heaters, central air conditioners, plumbing and electrical systems or fixtures.
- f. Non-structural alterations.

Where a building permit only includes the above types of work, and the total cost of such work is not more than \$10,000, the fee for the permit shall be \$5.00. Any change to a roof line shall be considered a structural alteration.
