**Section 1.** Village Code, Chapter 154 Water, Article I Water Rent Charges, §154-2. Water rate, originally adopted by the Board of Trustees of the Village of Cobleskill on May 19, 1997 as Local Law No. 2 of 1997 is hereby amended, as follows:

**§154-2. Water rate.**

A water rent charge will be imposed at the rate of twenty dollars and thirty cents (\$20.30) for the first five thousand (5,000) gallons of water charged, or fractional part thereof, and four dollars and six cents (\$4.06) for each one thousand (1,000) gallons of water charged, or fractional part thereof, thereafter.

**Section 2.** This Local Law shall take effect June 1, 2003.
