Section 1. Title

This Local Law shall be known and may be cited as a local law to amend the Water Code of the Village of Cobleskill.

Section 2. Findings of Fact

The Board of Trustees of the Village of Cobleskill seeks to remove from the property owner the undue financial burden of maintaining and repairing curb stops or valves and has been made aware that it is one of only a few communities that do not maintain the curb stops and valves.

Section 3. Changes to Chapter 154 of the Cobleskill Village Code

The following section in Chapter 154 shall now read as follows:

§ 154-11. Curb stops or valves.

- A. All residential curb stops or valves shall be maintained and repaired by the village.

- B. The Water Department will maintain residential one-inch service lines from the main to the residential side of the residential curb stop or valve including the residential curb stop or valve.
- C. Commercial property owners are responsible for maintaining fire line valves and curb valves in proper working order.

Section 4. Validity.

If any section, paragraph, sentence, clause, or phrase of this law is found to be invalid by a Court of competent jurisdiction, such Judgment shall not affect, impair, or invalidate the remaining portions of this law.

Section 5. Effective Date.

This law shall become effective immediately upon filing with the New York State Secretary of State.
