A local law Amendment to Chapter 36-2 (Duty of Residents regarding Sidewalks and Trees)

Replaces first paragraph of S 36-2 of the Village Code – all other paragraphs remain intact

S 36-2. DUTY OF RESIDENTS REGARDING SIDEWALKS AND TREES

It shall be the duty of every person and all persons owning or occupying premises in the Village to clear the sidewalk in front thereof from snow, dirt or other substance. For any and every neglect to comply with the foregoing provision, such person or persons shall be respectively liable to pay to the Village whatever expenses it may incur by reason of removing such snow, dirt or other substance. Whenever required by the Public Works Superintendent or by the Streets Superintendent to have snow, dirt or other substance removed, for every neglect to do so for the space of twenty-four (24) hours, such person or persons shall forfeit and pay to the village a penalty of twenty-five dollars (\$25.00) in addition to expenses incurred by the Village in removing snow, dirt or other substance.
