A local law Lake Access Launch Policy

Be it enacted by the Board of Trustees of the

It shall be illegal for any person to launch a boat into Lake Otsego at either of the Village launch sites at Fair Street or Fish Road during the period set by the Village Board of Trustees, when an attendant is present:

1. without submitting the boat and trailer for inspection for aquatic nuisance species, including zebra mussels, and;
2. without having the boat and trailer washed if so required by the attendant and;
3. without paying the launch fee as set by the Village Board of Trustees.

Violation shall be punishable by a fine not to exceed five hundred dollars (\$500).
