Section 1. Article IV of Chapter 215 of the Salina Town Code as enacted by Local Law No. 2 of 1997 is hereby amended to add § 215-15.1 as follows:

§215-15.1 DEDUCTIONS FROM INCOME:

- A. As prescribed by New York State Real Property Tax Law Section 467, applicants may deduct from their income all medical and prescription drug expenses which are not reimbursed or paid by insurance. Proof of the expenses and reimbursement, if any must be submitted with the application.
- B. As prescribed by New York Real Property Tax Law Section 467, applicants may deduct from their incomes veteran's disability compensation payments.

Section 2. Article VI of Chapter 215 of the Salina Town Code as enacted by Local Law No. 2 of 1999 is hereby amended as follows:

§215-21 MAXIMUM INCOME ELIGIBILITY LEVEL

The maximum income eligibility level shall be \$29,900.

§215-21.1 DEDUCTIONS FROM INCOME:

As prescribed by New York State Real Property Tax Law Section 459, applicants may deduct from their income all medical and prescription drug expenses which are not reimbursed or paid by insurance. Proof of the expenses and reimbursement, if any must be submitted with the application.




