§ 132-18. All night parking [amended 6-21-1989 by LL NO.6-1989; 10-21-1992 by LL No. 3-1992; 5-7-03 by L.L No. 1-2003].

Except in an emergency or when directed to do so by a police officer, no person shall park or stand or cause to be parked or stand any vehicle owned or controlled by such person upon any public highway or street in the Village of Corinth during snow removal periods between the hours of 11:00 p.m. and 6:00 a.m.
