## ARTICLE 1.)

Pursuant to Section 467 of the Real Property Law of the State of New York, the Town of Sangerfield, Oneida County, New York does hereby establish the following partial exemption from real property taxes for people sixty-five years of age and older based on graduated income eligibility levels between \$14,000 and \$19,699.99.

ANNUAL INCOME	PERCENTAGE ASSESSED VALUATION EXEMPT FROM TAXATION
\$ 0.00 ---- \$14,000.00	50%
\$14,000.01 ---- \$14,999.99	45%
\$15,000.00 ---- \$15,999.99	40%

\$17,000.00 ---- \$17,899.99	30%
\$17,900.00 ---- \$18,799.99	25%
\$18,800.00 ---- \$19,699.99	20%

## ARTICLE 2.)

This local law supercedes all prior local laws establishing eligibility levels.

This local law shall take effect immediately upon filing with the Secretary of State.
