## LOCAL LAW NO. 1 OF THE YEAR 2003

A LOCAL LAW TO AMEND SECTION 44-42.SCHEDULE XIII: ENTITLED  
"LIMITED TIME PARKING " TO ADD A TWO HOUR PARKING ZONE TO THE  
WESTERLY SIDE OF DIVISION STREET.

BE IT ENACTED by the Village Board of the Village of Delhi,

- Section 1: Section 44-42.Schedule XIII: shall be amended to add to the list of limited time parking the following; "Division Street Westerly Side 2 hours All times Beginning at a point 99 feet from the intersection of Main Street and ending at a point 198 feet from said intersection."
- Section 2: This Local Law shall take effect upon the filing with the Secretary of State of the State of New York.
