## LOCAL LAW NO. 3 OF THE YEAR 2003

### A LOCAL LAW TO AMEND THE DELHI VILLAGE CODE ADDING "NO PARKING ANY TIME" PROVISIONS TO CERTAIN LOCATIONS IN THE VILLAGE

BE IT ENACTED by the Village Board of the Village of Delhi,

Section 1. §44-38 "No Parking Any Time" is amended by deleting therefrom all regulations regarding parking on Orchard Street as heretofore passed by local law and substituting therefore the regulations as hereinafter set forth.

Section 2. §44-38 "No Parking Any Time" is amended to read as follows by the addition of the following parts of streets.

Name of Street	Side	Location
Elm Street	Both	From its intersection with Kingston Street for 30 feet southwesterly
Orchard Street	Easterly	From Main Street to Prospect Street
Orchard Street	Westerly	From Main Street for 60 feet
Orchard Street	Westerly	From 120 feet from Main Street to 450 feet from Main Street
Orchard Street	Both	From its intersection with Meredith Street for 45 feet northeasterly

Section 3 This local law shall take effect upon the filing with the Secretary of State of the State of New York.
