A LOCAL LAW TO AMEND PARKING, STANDING AND STOPPING RESTRICTIONS FOR KIEFFER AVENUE"

Be it enacted by the Board of Trustees of the Village of Depew, New York as follows:

Parking, standing and stopping restrictions as hereinafter enumerated shall apply on the following streets. Wherever no restrictions are enumerated, no special restrictions apply except as otherwise provided in this Chapter or designated by the Chief of Police pursuant to Section 60.03 hereof.

107. KIEFFER AVENUE

NO PARKING ANYTIME on the east side of Kieffer Ave. from its south end northerly to a point approximately one hundred thirty four feet (134') from its intersection with its south curb line of Broadway.

NO PARKING HERE TO CORNER on the east side of Kieffer Ave. between its intersection with the south curb line of Broadway to a point one hundred thirty four feet (134') south on Kieffer Ave.

NO PARKING HERE TO CORNER on the west side of Kieffer Ave. between its intersection with the south curb line of Broadway to a point one hundred twenty four feet (124') south on Kieffer Ave.

ADOPT/TABLE/DENY PROPOSED LOCAL LAW #4 OF THE YEAR 2003 –
PARKING, STANDING AND STOPPING RESTRICTION

Trustee Maryniewski, offered the following resolution and moved for its adoption:

BE IT RESOLVED, parking, standing and stopping restrictions as hereinafter enumerated shall apply on the following streets. Wherever no restrictions are enumerated, no special restrictions apply except as otherwise provided in this Chapter or designated by the Chief of Police pursuant to Section 60.03 hereof.

107. KIEFFER AVENUE

Delete: No parking on the east side or west side of Kieffer Avenue between the south curb line of Broadway and the south end of Kieffer Avenue, between the hours of 10:00 PM and 7:00 AM (Added LL #1, 1976, eff. 2/20/76; Amd LL #10, 1977 eff. 12/23/77).

Add: NO PARKING ANYTIME on the east side of Kieffer Ave. from its south end northerly to a point approximately one hundred thirty four feet (134') from its intersection with its south curb line of Broadway.

NO PARKING HERE TO CORNER on the east side of Kieffer Ave. between its intersection with the south curb line of Broadway to a point one hundred thirty four feet (134') south on Kieffer Ave.

NO PARKING HERE TO CORNER on the west side of Kieffer Ave. between its intersection with the south curb line of Broadway to a point one hundred twenty four feet (124') south on Kieffer Ave.

NOW THEREFORE BE IT RESOLVED, Local Law #4 of the Year 2003 is hereby **ADOPTED**.

The foregoing resolution was seconded by Trustee Mazur, and duly put to a roll call vote which resulted in the following:




