Local Law No. 3 of the year 2003

A local law to amend the Zoning Map of the Town of Schodack under Town Code Section 219-8 to change the zoning classification of property from R-40 to Highway Commercial.

Be it enacted by the Town Board of the Town of Schodack as follows:

Section 1.

The Zoning Map of the Town of Schodack is hereby amended to change the zoning classification for property known as 3517 US Route 20 from R-40 and Highway Commercial to be entirely in the Highway Commercial Zone, for the area shown on attachment A.

Section 2.

This Local Law shall become effective upon filing in the Office of the Secretary of State.
