Section 1. Section 27-43 of the Local Law No. 4 of the Year 1982 as most recently amended by Local Law No. 4 of the Year 1997, is hereby amended as follows:

Section 27-43 Determination of rates

Sewer Service Charges shall be as determined by resolution of the Board of Trustees.

Section 2. This Local Law shall take effect on July 1, 2003, and upon filing with the Secretary of State.
