SECTION I. Pursuant to the authority conferred by Town Law Section 34(2), the Town Board of the Town of Schroepfel hereby provides that the Comptroller of the Town of Schroepfel shall henceforth have the power and perform the duties set forth in subsections (a) and (b) of Section 2 of the Town Law Section 34.

SECTION II. This Local Law shall take effect immediately upon its filing with the Secretary of State.
