BE IT ENACTED by the Board of Trustees of the Village of East Hampton as follows:

SECTION II. The provisions of §54-7.A of the Code of the Village of East Hampton are hereby amended as follows:

§54.7.(A) Vehicle & Traffic; Parking Time Limited In Designated Locations.

- (23) On the east side of Park Place beginning at a point 210 feet from the intersection of Main Street and Park Place and extending north for a distance of 42 feet and beginning at a point 262 feet from the intersection of Main Street, extending north to a point 473 feet from the intersection of Main Street & Park Place and on the north side of Park Place beginning at a point 263 feet from the intersection of Park Place and Newtown Lane extending east 137 feet for a period of time in excess of 15 minutes, during the period from May 1 to and including December 31.
