Section 1. Amend Chapter 73 of the Shelter Island Town Code, titled "Garbage, Rubbish and Refuse" as follows:

Section 73-4 (B) shall be amended to read as follows:

- (1) Dispose of non-recyclable household waste except in a Town garbage bag as defined herein, except for
 - a. users bringing in large or unbaggage waste, who shall pay a fee based on weight as established by resolution of the Town Board, and
 - b. customers of a commercial hauling business having a contract with the Town of Shelter Island, in which case the hauler shall pay the Town a designated fee per ton brought to the disposal area, as set forth in the contract, and
 - c. not-for-profit organizations who have signed an agreement with the Town to pay the designated bag fee, or its equivalent, for non-recyclable waste deposited in the disposal area.
- (2) Duplicate or imitate a Town garbage bag.
- (3) Give, sell or issue in any manner a duplicated or imitated Town garbage bag.

Section 2. Effective Date. This Local Law shall be filed with the Secretary of State and become effective March 1, 2003.
