A local law Moratorium on Residential Subdivision Reviews and

FIRST: Chapter 214 of the Code of the Incorporated Village of East Hills is amended by adding a new Section as follows:

ARTICLE XXIV

Moratorium on Residential Subdivision Reviews and Approvals

§214-614 Application of Article.

The provisions of this Article shall apply in residence zone districts of the Village.

§214-615 Moratorium on Subdivisions.

Commencing upon the effective date of this local law, no applications for subdivision plats submitted to the Incorporated Village of East Hills, its Building Department, and/or its Planning Board, shall be accepted, nor shall any pending applications for same be reviewed or processed for a period of one-hundred eighty calendar days (180) following the meeting of the Board of Trustees on March 24, 2003.

§214-616 The purpose of this moratorium is to enable the Village sufficient time to review, study, hold public hearings, and prepare and adopt a comprehensive plan concerning the creation of new residential subdivisions.

§214-617 Subdivision applications which have been submitted and approved prior to the date of the public hearing on this matter shall not be subject to this moratorium.

SECOND: Separability.

If any word, phrase, clause, sentence, or section of this local law is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this local law.

THIRD: Effective Date.

This local law shall take effect immediately upon filing with the Secretary of State as provided by law.
