CHAPTER 245 - STREETS AND SIDEWALKS

ARTICLE III  
CIVIL CLAIMS NOTICE

Section 245-12. Compliance required.

No civil action shall be maintained against the Town of Smithtown, the Town of Smithtown Water District, the Town of Smithtown St. James Water District, the Town of Smithtown Industrial Development Agency, the Town of Smithtown Housing Development Corporation, the Town of Smithtown Multifamily Housing Corporation, the Town of Smithtown Parking District, the Town of Smithtown Department of Parks, the Town of Smithtown Department of Recreation, the Town of Smithtown Highway Department or the Town of Smithtown Traffic Safety Department or Town of Smithtown Community Development Agency or any other department or agency of the Town of Smithtown unless the requirements of this Article are fully met.


