## Section 1. Legislative Intent

It is the intent of this local law to assure the continued safe and efficient operation of the Village of Forestville while the process of dissolution unfolds. Voters of the Village Of Forestville have voted to dissolve the Village Government however, the operations of the village must continue until the actual dissolution pursuant to a plan of dissolution adopted by the Village Board; and

The Village Board has determined that the loss of employees currently working for the village could be difficult, if not impossible to replace, leaving the residents unsafe and without necessary services in advance of the actual dissolution and transfer of duties.

## Section 2. Employees Designated as essential

The Board has determined that it would be in the best interests of the village residents to assure continuity of operations until the actual dissolution and the Village Board determines that the employment titles and the current employees holding certain titles identified as positions in the Department of Public Works, Clerk II, Account Clerk, and Village Auditor, are essential to the continued operations of the village until dissolved.

### **Section 3. Compensation for continued service**

To entice current employees to remain on the job and thus assuring provision of necessary services, the Board determines that each employee holding a position or title identified in Section 2 on the last day of the existence of the Village of Forestville shall receive Five (5) weeks of severance pay at their regular hourly rate of pay. To qualify for the pay employees must continue in employment with the Village of Forestville, without interruption and remain so employed by the Village of Forestville at the time of the actual dissolution of the Village.

Said Sum will accrue to the employee and be a charge against village funds at 11:59 P.M on the final day of existence of the Village of Forestville.

### **Section 4. Effective Date**

This local law shall be effective upon filing with the Secretary of State of the State of New York pursuant to Municipal Home Rule Law.
