A local law to amend Local Law Number 70-4 of the Village of Cassadaga, providing for maintenance and charges for water supplied by the Village of Cassadaga to users within the Village and others.

Be it enacted by the Board of Trustees of the CASSADAGA

SECTION 1. Section 7, Paragraph E of the VILLAGE OF CASSADAGA Local Law 70-4 is hereby amended as follows:

Section 7. Water rates, service tap charges and meter deposits  
Paragraph E. All water rates shall become due semi-annually on the first day of June and December of each year. Water rates shall be paid semi-annually before the twenty-fifth (25) day of the month in which they become due. All water bills not paid on or before the twenty-fifth (25th) day of the month in which they become due will be charged on the gross rate. The gross rate shall be ten percent (10%) above the net rate.

SECTION II. Section 7, Paragraph F of the VILLAGE OF CASSADAGA Local Law Number 70-4 is hereby amended as follows.

Section 7. Water rates, service tap and meter deposits  
Paragraph F. If water rates for any premises remain unpaid for (60) days or a longer period of time after becoming due, the supply of water to said premises may be shut off without further notice and will not be restored until all past due rentals are paid. A charge of five dollars (\$5) payable in advance will be made when water service is restored.

SECTION III. This local law shall take effect upon filing with the Secretary of State.
