
§ 101-10. Parking prohibited.

The parking of vehicles is hereby prohibited in the locations as follows:

Prospect Place	East	From its intersection with the northeasterly curb line of East Main Street (Route 25) to a point 25 feet north
Prospect Place	West	From its intersection with the northeasterly curb line of East Main Street (Route 25) to a point 25 feet north

Street	Side	Hours	Location
Prospect Place	East	1:00 a.m. to 6:00 a.m.	From its intersection with the northeasterly curb line of East Main Street (Route 25) from a point 25 feet north to a point 150 feet north
Prospect Place	West	1:00 a.m. to 6:00 a.m.	From its intersection with the northwesterly curb line of East Main Street (Route 25) from a point 25 feet north to a point 125 feet north
