Local Law No. - 2 - of the year 2003

TO AMEND SECTION: 119-9 Inspection and re-inspection of
electrical installations

The chief inspector and each of the duly appointed inspectors of the New York Board of Fire Underwriters, Electrical Inspectors Inc., and/or Electrical Inspection Service Inc. are hereby authorized and empowered to make inspections and re-inspection of all electrical installations heretofore and hereafter made or described and to approve or disapprove the same within the Village of Cedarhurst. Said New York Board of Fire Underwriters, Electrical Inspectors Inc. and/or Electrical Inspection Service, Inc. shall be independent contractors and shall not be deemed agents of the Village of Cedarhurst, and they shall provide liability insurance policies on which the Village of Cedarhurst shall be designated as an additional insured as its interest may appear. Said New York Board of Fire Underwriters, Electrical Inspectors Inc. and/or Electrical Inspection Service, Inc. shall hold the Village of Cedarhurst free and harmless from any and all claims for injuries, property damage or otherwise arising out of any such inspection, re-inspection or failure to conduct the same. In no event shall any cost or expense of any such inspections and/or re-inspection be a charge against the Village of Cedarhurst. The aforementioned liability insurance policies shall be written by insurance companies acceptable to and/or approved by the Village of Cedarhurst and shall be in coverage limits of not less than \$5,000,000 in the aggregate, including primary and excess insurance coverage, if any.
