BE IT ENACTED by the Board of Trustees of the Village of East Hampton as follows:

SECTION II. Section 57-6 B of the Code of the Village of East Hampton are hereby amended as follows:

§57-6. General provisions.

- (1) The requirements of this section shall apply to all nonresidential properties and districts throughout the Village of East Hampton, including any and all properties subject to the issuance of a special permit.
- (2) In the interest of pedestrian and traffic safety and in order to alleviate an undue burden on public streets and minimize traffic congestion, any project which is required to obtain site plan approval, and any modification which constitutes an intensification as defined herein, shall comply with the applicable parking requirements of this section. No building or structure lawfully in use at the effective date of this chapter shall be enlarged, nor shall the use of any property lawfully existing at the effective date of this chapter be changed or extended or enlarged or expanded, unless the off-street parking and truck loading space requirements are complied with.

(a) Exemptions.

- [1] Existing seating capacity and number of employees (as used in determining parking demand) of restaurants, bars, nightclubs, discos, dance halls and places of public assembly as established prior to the effective date of this section.
- [2] A change without enlargement to a different permitted use having the same parking and loading requirements.
- [3] Units existing prior to the effective date of this section.




