



TOWN OF SKANEATELES LOCAL LAW NO. 2-2003

**"The 2003 Disabled Persons Tax Exemption
Local Law of the Town of Skaneateles"**

Be it enacted by the Town Board of the Town of Skaneateles as follows:

§134-13. Partial Tax Exemption for the Disabled.

Effective July 29, 1998, New York Real Property Tax Law Section 459-c authorizes a Town to provide a partial real property tax exemption for real property owned by persons with disabilities whose incomes are limited by reason of such disabilities.

§134-14. Schedule; Income Limits.

New York Real Property Tax Law Section 459-(c)(1)(b) further authorizes a Town to adopt such an exemption to the extent provided in the following schedule:

<u>EXEMPTION</u>	<u>INCOME LIMITS</u>
50%	\$21,500.00
45%	\$22,500.00
40%	\$23,500.00
35%	\$24,500.00
30%	\$25,400.00
25%	\$26,300.00
20%	\$27,200.00
15%	\$28,100.00
10%	\$29,000.00
05%	\$29,900.00

§134-15. Applicability.

Subject to and as defined in the provisions of Real Property Tax Law Section 459-c, a partial real property tax exemption is hereby authorized for property owned by persons with disabilities whose income is limited by reason of such disability as specifically provided and determined by Section 459-c.

§134-16. Maximum Income Levels.

The income eligibility levels for such exemption are hereby established at the maximum amounts authorized by Real Property Tax

Law Section 459-(c)(1)(b), as described in Section B of this Local Law.

§134-16.1. Effective Date.

This Local Law shall take effect immediately upon its filing with the Secretary of State.
