Section 1. Section one hundred ninety-seven dash five of the Code of the Town of Hempstead as constituted by local law number one of nineteen hundred and sixty-nine, said Section last amended by local law number eighty-eight of two thousand five is hereby amended by including therein "ARTERIAL STOPS" at the following locations:

HASTINGS STREET (TH 432/05) – STOP – all traffic northbound on Milburn Avenue shall come to a full stop.

HASTINGS STREET (TH 432/05) – STOP – all traffic southbound on Milburn Avenue shall come to a full stop.

MILBURN AVENUE (TH 432/05) – STOP – all traffic eastbound on Ocean Avenue shall come to a full stop.

MILBURN AVENUE (TH 432/05) – STOP – all traffic eastbound on Adams Street shall come to a full stop.


