Section 1. Section one hundred ninety-seven dash five of the Code of the Town of Hempstead as constituted by local law number one of nineteen hundred and sixty-nine, said Section last amended by local law number seventy-one of two thousand eight is hereby amended by including therein "ARTERIAL STOPS" at the following locations:

BALDWIN

CHURCH STREET (TH 454/08) – STOP – all traffic southbound on Harvard Place shall come to a full stop.

CHURCH STREET (TH 454/08) – STOP – all traffic northbound on Bayview Avenue shall come to a full stop.

HARVARD AVENUE (TH 522/08) – STOP – all traffic northbound on Pine Street shall come to a full stop.

HARVARD AVENUE (TH 522/08) – STOP – all traffic southbound on Pine Street shall come to a full stop.

BELLEROSSE TERRACE

238th STREET (TH 420/08) – STOP – all traffic westbound on Superior Road shall come to a full stop.

JERICHO TURNPIKE (TH 420/08) – STOP – all traffic northbound on 225th Street shall come to a full stop.

BEDFORD AVENUE (TH 242/08) – STOP – all traffic northbound on Clinton Street shall come to a full stop.


