Article 6 of the Zoning Law of the Town of Champion is amended by the adoption of Section 680 as follows:

A. All driveways located in the Town of Champion, in addition to being in compliance with the Laws, Rules, and Regulations of any Government or Governmental Agency having jurisdiction thereof shall also be constructed in compliance with Section 3.8 of the Highway Standards in the Town of Champion adopted as Local Law No. 2 of the year 1998.
