### Section 1. Authority.

This local law is enacted pursuant to §1402, subdivision 3 of the Real Property Tax Law of the State of New York.

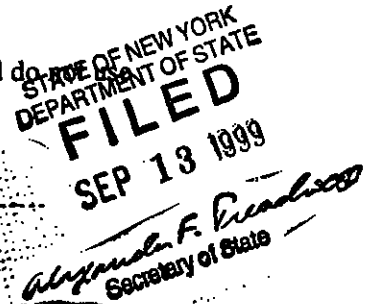
### Section 2. Purpose.

The Village of Castorland shall cease to be an assessing unit for purposes of the Real Property Tax Law of the State of New York and the Village taxes shall thereafter be levied on a copy of the part of the Town of Denmark assessment roll as applicable to said Village only, beginning with the year 2000.

### Section 3. Effective Date.

The within local law is subject to a permissive referendum and will take effect thirty days after its adoption.
