A local law For Annexation of Territory into Village

as follows:

Section 1. Legislative Authority

The Village Board of the Village of Castorland, pursuant to the authority granted to it by Article 17 of the General Municipal Law; the Municipal Home Rule Law; and the Resolution, Findings and Order adopted by the Town Board of the Town of Denmark and Village Board of the Village of Castorland hereby enacts as follows:

Section 2. Statement of Purpose

The following described territory situated in the Town of Denmark shall be annexed into the Village of Castorland:

- A Village of Castorland water tower located North of Kitts Corners, Naumburg, Road, Denmark, New York. The subject property is a parcel of land approximately 100 feet by 125 feet in dimension. The subject property is also known as tax parcel number 126.00-02-12.200;
- B. Vacant land owned by Village View Farms, LLC located North of Kitts Corners, Naumburg Road, Denmark, New York. The subject property is a part of a parcel approximately 410 feet by 130 feet and 210 feet by 1190 feet. The subject property is also known as part of tax parcel number 126.00-02-12.1;
- C. Village of Castorland water supply located at the North side of State Route 410, Denmark, New York. The subject property consists of approximately 3.80 acres and is also known as tax parcel number 127.00-01-25;
- D. Village of Castorland sewage treatment plant located at the North side of State Route 410, Denmark, New York. The subject property consists of approximately 13.80 acres and is also known as tax parcel number 127.00-01-24;

- E. Vacant land owned by Elmer Moser and sons located at the North side of State Route 410, Denmark, New York. The subject property consists of approximately 150 feet by 200 feet and is also known as part of tax parcel number 127.00-01-27; and
- F. Vacant land owned by Eugene Zehr located at the North side of State Route 410, Denmark, New York. The subject property consists of approximately 660 feet by 200 feet and is also known as part of tax parcel number 127.00-01-26.

Section 3. Effective Date

This Local Law shall take effect upon filing with the Office of the Department of State as required by the provisions of the Municipal Home Rule Law and the General Municipal Law.
