Section 1. Section one hundred ninety-seven dash five of the Code of the Town of Hempstead as constituted by local law number one of nineteen hundred and sixty-nine, said Section last amended by local law number three of two thousand six is hereby amended by including therein "ARTERIAL STOPS" at the following locations:

BALDWIN

VERITY LANE (TJI 754/05) – STOP – all traffic eastbound on Allen Place shall come to a full stop.

BELLMORE

JOHNSON PLACE (TH 520/05) – STOP – all traffic traveling eastbound on Wilson Avenue shall come to a full stop.

JOHNSON PLACE (TH 520/05) – STOP – all traffic traveling westbound on Wilson Avenue shall come to a full stop.

<b>LEVITTOWN</b>	<b>EAGLE LANE (TH 003/06) – STOP – all traffic traveling northbound on Long Lane shall come to a full stop.</b>
<b>MERRICK</b>	<b>OLD MILL ROAD (TH 697/05) – STOP – all traffic traveling southbound on Newell Road shall come to a full stop.</b>
<b>OCEANSIDE</b>	<b>JACKSON STREET (TH 676/05) – STOP – all traffic approaching northbound on Westlake Avenue shall come to a full stop.</b>  <b>JACKSON STREET (TH 676/05) – STOP – all traffic approaching southbound on Westlake Avenue shall come to a full stop.</b>

<b>UNIONDALE</b>	<b>EMERSON STREET (TH 694/05) – STOP – all traffic westbound on Hempstead Boulevard shall come to a full stop.</b>  <b>EMERSON STREET (TH 694/05) – STOP – all traffic eastbound on Hempstead Boulevard shall come to a full stop.</b>
<b>WANTAGH</b>	<b>BARRIE AVENUE (TH 524/05) – STOP – all traffic traveling west on Douglas Avenue (north leg) shall come to a full stop.</b>
<b>WOODMERE</b>	<b>FAIRWAY DRIVE (TH 550/05) – STOP – all traffic approaching westbound on Clubhouse Road shall come to a full stop.</b>  <b>GREEN PLACE (TH 550/05) – STOP – all traffic approaching westbound on Tee Court shall come to a full stop.</b>  <b>LAKESIDE DRIVE SOUTH (TH 550/05) – STOP – all traffic approaching northbound on Fairway Drive shall come to a full stop.</b>




