DEPARTMENT OF STATE

A local law Amending Local Law 1 of 1997 Pertaining to the Operation of All-Terrain Vehicles on Town of Edwards Highways.

Be it enacted by the Town Board of the  
(Name of Legislative Body)

Town of Edwards as follows:

Local Law Number 1 of the year 1997 is hereby amended to add the following:

**SECTION III. DEFINITIONS:**

5. **MUNICIPAL GOVERNMENT OWNED PROPERTY** shall mean the real property owned, leased or used by the Town of the Edwards, Edwards Central School System, or any local government agencies.

**SECTION V. CONDITIONS AND RESTRICTIONS:**

8. It shall be unlawful to operate any power driven vehicle designed as an "all terrain vehicle" or "off road vehicle", including but not limited to those vehicles which under the Motor Vehicle Laws of the State of New York cannot be registered, in the following designated areas in the Town of Edwards: Edwards Central School properties; Town of Edwards garage lot; Town Park at corner of Main and Church Streets; Town parking lot on Main Street; cemeteries and Town lot adjacent to Fairview Cemetery; Town sewer plant lot (except paved driveway and an established existing dirt trail crossing the property in the direction of Church Street); property of Edwards Housing Authority (including driveways) and all sidewalks in the Town.
9. It shall be unlawful to operate "all terrain vehicles" and/or "off road vehicles" which make a loud, unnecessary, or unusual noise so as to disturb or interfere with the peace and quiet of other persons in any manner which constitutes a

public nuisance, annoys, injures, or endangers the health, safety, comfort or repose of the public.

All other provisions of Local Law Number 1 of 1997 shall remain in full force and effect.

Effective Date - This Local Law shall take effect upon filing with the Secretary of State, State of New York, pursuant to the provisions of the Municipal Home Rule Law.

Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or, if there be none, the chairman of the county legislative body, the mayor of a city or village, or the supervisor of a town where such officer is vested with the power to approve or veto local laws or ordinances.

**5. (City local law concerning Charter revision proposed by petition.)**

I hereby certify that the local law annexed hereto, designated as local law No. \_\_\_\_ of 20\_\_, of the City of \_\_\_\_\_ having been submitted to referendum pursuant to the provisions of Section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the (special)(general) election held on \_\_\_\_\_, 20\_\_, became operative.


**6. (County local law concerning adoption of Charter.)**


