A local law A Local Law Amending the Town of Champion Sewer Use Law

Be it enacted by Town Board of the

Article 1. – Statement of Authority. The Town Board of the Town of Champion, pursuant to the authority granted it under Article 12a of the Town Law and Sections 10 and 20 of the Municipal Home Rule Law of the State of New York, hereby enacts as follows:

Article 2. – Statement of Purpose and Findings. The Town Board of the Town of Champion hereby finds that it is necessary to amend its Sewer Use law to have it conform to billing practices for vacant land. It is the purpose of this Local Law to amend the Table of Equivalent Dwelling Units in Article 12 of the Sewer Use Law to reflect te proper charge for vacant land.

Article 3. – Enactment. The Town Board of the Town of Champion hereby amends Article 12 of its Sewer Use Law and more to amend the Table or Equivalent Dwelling Units to add to the following:

Vacant Land EDU Assessment

0.5

Article 4. – Severability. If any part of this local law shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this local law.

Article 5. – Effective Date. This local law shall take effect immediately upon filing with the Secretary of State.




