**Article 1. – Statement of Purpose and Findings.** The Town Board of the Town of Champion did on the 14th day of October, 2014, pass Local Law No. 1 of the year 2014 which overrode the tax cap for the year 2014. After passing the budget and completing the budget year, it has been determined that the Town of Champion did not exceed the tax cap amount and therefore intends to rescind Local Law No. 1 of the year 2014.

**Article 2. – Recind of Local Law No. 1 of 2014.** The Town of Champion does hereby rescind and repeal Local Law No. 1 of the year 2014.

**Article 3. – Severability.** If any part of this local law shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this local law.

**Article 4. – Effective Date.** This local law shall take effect immediately upon filing with the Secretary of State.




