A local law A Local Law Opting out of the Tax Exemption Provided by Section 487 of the Real Property Tax Law

Be it enacted by Town Board of the
(Name of Legislative Body)

Article 1. – Statement of Purpose and Findings. The Purpose of this Local Law is to provide that no tax exemption shall be given in the Town of Champion for a solar or wind energy system or farm waste energy system as defined in Section 487 of the Real Property Tax Law.

Article 2. – Enactment. The Town of Champion does hereby provide that no exemption under Section 487 of the Real Property Tax Law shall be applicable within the Town of Champion with respect to any solar or wind energy system or farm waste energy system as defined in Section 487 of the Real Property Tax Law and constructed after the effective date of this Local Law.

Article 3. – Severability. If any part of this local law shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this local law.

Article 4. – Effective Date. This local law shall take effect immediately upon filing with the Secretary of State.




