A local law A Local Law Reducing the Exemption in the Town of Champion as provided under Section 485-B of the Real Property Tax Law

Be it enacted by Town Board of the

Article 1. – Statement of Purpose and Findings. The Town of Champion has deemed it in the best interests of the citizens of the Town of Champion that the exemption allowed under Section 485-b of the Real Property Tax Law be reduced pursuant to Law to zero.

Article 2. – Enactment. The Town of Champion does hereby reduce the percentum of exemption allowed pursuant to Section 485-b of the Real Property Tax Law to zero.

Article 3. – Filing and Compliance. A copy of this Local Law shall be filed with the Assessor of the Town of Champion.

Article 4. – Severability. If any part of this local law shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this local law.

Article 5. – Effective Date. This local law shall take effect immediately upon filing with the Secretary of State.




