**INCORPORATED VILLAGE OF AMITYVILLE: LOCAL LAW # 12 OF YEAR 2016**

A local law to amend Chapter 172, of the Code of the Village of Amityville, Section 172-48, Schedule I: Stop Intersections thereof, by designating stop streets at the intersections of Avon Place and Lake Drive; and Grand Central Avenue and Perkins Avenue.

BE IT ENACTED by the Board of Trustees of the Inc. Village of Amityville as follows:

Section 1. Amend CVA §172.48, Schedule I, by adding and designating the following described locations as stop streets at the intersection indicated:

<b>Stop Sign</b>	<b>Direction of Travel</b>	<b>At Intersection of</b>
Avon Place	East and West	Lake Drive
Grand Central Avenue	North and South	Perkins Avenue
