A local law Prohibiting Parking in the Event of a Forecast of Snow

Be it enacted by the Board of Trustees of the  
(Name of Legislative Body)

of New Square as follows:

that Local Law #1 of 1965 Paragraph 2 and Local Law #1 of 1993 Paragraph 10B are hereby amended to read as follows:

“It shall be unlawful for any person to place, park or leave any automobile, truck or other vehicle on any public road or street within the corporate limits of the Village of New Square, New York, in the event of a forecast of and/or after a fall or precipitation of snow of two inches or more, unless such automobile, truck or other vehicle is at all times attended by and in the charge of a person capable of operating it. Such parking prohibition shall remain in effect until the snowfall has ceased and all snow has been removed or cleared from such public road or street. All parked or unattended vehicles remaining on any public road or street in violation of this provision shall be towed away at the owner’s expense.”
