Local Law No. 5 of the year 2016

DEPARTMENT OF STATE

A local law entitled: "To Amend the Location of Parking Stalls in the Village of Camillus".

Be it enacted by the Village Board of the Village of Camillus, Onondaga County, New York as follows:

Section One (1).

Section 110-7 of The Code of the Village of Camillus is amended by adding the following definition:

"Driveway: Land used by vehicular traffic as access to and situated on the property or lot; such land shall be a hard-surfaced area of stone, gravel asphalt, brick pavers or concrete."

Section Two (2).

"Section 110-46. Location of Parking Stalls" is deleted in its entirety.

Section Three (3).

A new Section 110-46 is adopted as follows:

"§110-46. Location of Motor Vehicle Parking Spaces.

- A. Front Yards. No motor vehicle shall be parked within a front yard in any district except that portion improved with a driveway.
- B. Corner lot side yards. No motor vehicle shall be parked contiguous to a right-of-way, except in driveways that are perpendicular to the right-of-way.
- C. Side and rear yards. No motor vehicle shall be parked within five feet of any rear lot line or within five feet of any side lot line, except in driveways that do not extend beyond the rear of the principal structure on the lot.
- D. Notwithstanding anything contained herein to the contrary, in a C District, the area between adjoining facilities contiguous to that portion of the yard area having a lot line common to both adjoin lots may be occupied by stalls."

This Local Law will take effect immediately upon filing with the New York State Secretary of State.

Upon motion made by Trustee Waterman, and seconded by Trustee Walsh the foregoing resolution was put to a roll call, which resulted as follows:



The resolution was approved.


LOCAL LAW CERTIFICATION


