ARTICLE I: The purpose of this Local Law is to realign the two (2) year elective term of the Tax Collector so that the term begins and ends at the same time as the other local elective offices in the Town of Western.

ARTICLE II: The elective term of the Tax Collector shall be changed from two (2) years to one (1) year for a single one (1) year term effective January 1, 2019 until December 31, 2019.

ARTICLE III: The elective term of the Tax Collector shall thereafter be two (2) years, effective January 1, 2020.

ARTICLE IV: This Local Law is subject to a mandatory referendum of the qualified electors of the Town of Western at the next general election to be held on November 8, 2016.
