A local law to amend Chapter 131, Article XIV, Section 59 of the Town Code concerning Water

as follows:

Section 1. Chapter 131, Section 59 of the Code of the Town of New Castle, entitled "Penalty for Unpaid Water Charges" is hereby amended as follows:

§ 131-59. Penalty for unpaid water charges.

A. Unpaid water charges in arrears for 30 days or longer shall be subject to a penalty of 10% of the amount due. Penalties imposed for late payments of water bills may be waived only if the late payment or the imposition of the penalty was due to an error made by the Town or as provided for in 131-59(B). Any request for such a waiver must be made in writing and addressed to the Town Comptroller. The Town Comptroller may waive any such penalty upon a recommendation to do so from the Commissioner of Public Works and the Town Administrator and the Town Board may review and overrule or modify any decision by the Town Comptroller.

B. The Town Comptroller shall have the authority to bill at regular water rates for consumption rather than the higher volume rate only when the Account Holder's consumption exceeds the Account Holder's average quarterly consumption by ten times over the prior four quarters. Any request for such a reduced charge must be made in writing and addressed to the Town Comptroller.

Section 2. Ratification, Readoption and Confirmation

Except as specifically modified by the amendments contained herein, the Chapter 131 of the Town of New Castle is otherwise to remain in full force and effect and is otherwise ratified, readopted and confirmed.

Section 3. Numbering for Codification

It is the intention of the Town of New Castle and it is hereby enacted that the provisions of this Local Law shall be included in the Code of the Town of New Castle; that the sections and subsections of this Local Law may be re-numbered or re-lettered by the Codifier to accomplish such intention; that the Codifier shall make no substantive changes to this Local Law; that the word "Local Law" shall be changed to "Chapter," "Section" or other appropriate word as required for codification; and that any such rearranging of the numbering and editing shall not affect the validity of this Local Law or the provisions of the Code affected thereby.

Section 4. Severability

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid or unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words or parts of this Local Law or their petition to other persons or circumstances. It is hereby declared to be the legislative intent that this Local law would have been adopted if such illegal, invalid or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and if such person or circumstance to which the Local Law or part hereof is held inapplicable had been specifically exempt there from.

Section 5. Effective Date

This local law shall take effect immediately upon filing with the Office of the Secretary of State.

5. (City local law concerning Charter revision proposed by petition.)


6. (County local law concerning adoption of Charter.)
